



- n) The trust shall carry out its objects without any profit motive.





- f) In case of difference of opinion arising among the trustees and in all matters wherein the trustees shall have a discretionary power the opinion of the majority of the trustees present and voting shall prevail and be binding on all the trustees
- g) In case of any vacancy in the trust Board arising by death or resignation or otherwise of any trustee the remaining trustees will have full powers to represent the trust Board.
- h) Even when the post of a trustee is vacant the reason that the said post has not been filled up will not render the acts and deeds and proceedings which the other trustees have done
- i) The trust Board shall convene its meeting once in every three months. If necessary their meeting can be convened at any time within three months. The secretary in consultation with the chairman shall first inform the date agenda and the venue of the trust Board meeting to all trustees one week in advance to the date of meeting. For urgent deeds resolutions can be arrived at by means of circular by. The Chairman of the Board meeting. If the trust Board Chairman is absent than the other trustees shall elect one among them to preside over the meeting. Resolutions can be arrived at either unanimously or as per favour by majority of the trustees. If the casting of votes for the resolutions for and against is equal then the president of the meeting shall cast his vote and conclude the passing of resolution. If any trustee acts against the objects of the trust then he shall be removed by passing resolutions therefore accepted by majority of the members in the trust Board meeting.

BANK ACCOUNTS :

The trustees shall have power to deposit the trust moneys or any portion there of in nationalized bank or in any scheduled bank or post office ether by way of fixed deposit or SB Account or Current Account jointly by two trustees one of whom shall be the managing trustee and the trust bank accounts shall be operated by the managing trustee Sri V. Ayyappan along with any one of the trustees Sri P. Ramasubramanian.

4. 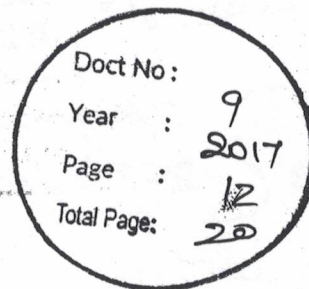
